1 **RFP Update**

- RFP has been released by the City
- The Committee raises concerns over the language used in regards to housing and approves a call for the Board to ament the RPF to include wording that stresses housing is still a proposal pending community consultation and wishes to remove/ adjust phrasing that implies housing has been approved.
- The committee is concerned with putting housing and child care over a pool or up multiple stories (small children going down multiple flights of stairs in fire drills) and raise concern with the logistics and potential health risks of child care being situated over a pool.

2 Children, Families, and Educators Committee

- The Children, Families and Educators committee is close to finalizing its name, guiding principles and special requirements.

Discussion:

- The logistics of having childcare spaces anywhere but at ground level.
- The potential to lose existing childcare programming (after school care and pre-school) in favor of infant and toddler care.
- Britannia should be keeping with progressive child care initiatives and continue being a pioneer in the field.
- The possibility of developing a child care HUB ensuring dedicated spaces for children and families at all levels of development rather than separate child care spaces and multi-purpose rooms that are utilized under the 'pull out' style of programming sharing room usage with other programs on site.
